Please do so by at least attending the breakfast or sending in your support check in honor of **Brother Larry Quane** who was a tireless defender of unborn life. I will be traveling to **Washington DC** again this year with my wife Luann to participate on a National level, and represent the **Rock Island Knights of Columbus** in the support of pre-born life. We will meet our Daughter, Sr. Bernadette Therese and the **Sisters of Life** at the *John Cardinal O'Connor Conference of Life* to be held this year on Jan. 20th at Catholic **Georgetown University**, then the Opening Mass for the March for Life being held the next day at the **Basilica of the National Shrine of the Immaculate Conception** on the Campus of Catholic **Washington University**, and the actual **March for Life** taking place on Wednesday January 22nd, commemorating the lives of more than 56 million pre-born human being babies whose willful taking of their lives is a National Tragedy. DEACON'S QUESTION BOX

How Many Times May Communion be Received Each Day?

I was asked recently if Communion could be received more than once per day. For several centuries, the limit was once per day. Does that still apply today especially now that Sunday Mass may be anticipated on Saturday evening?

Over the centuries, extremes have dictated the Church's laws on the reception of Communion. For a period of time during the Middle Ages, reception of Communion became very rare as people never felt they were worthy. That drove the creation of the precept mandating all Catholics receive at least once per year.

Then there were those that believed that if receiving once was good, receiving multiple times would be even better. We know that we receive all of Jesus, body, blood, soul, and divinity, each time we receive. So this becomes an abuse and needed to be limited. So a canon law limiting Catholics to receive only once per day. The rule did allow a second reception if participating in a funeral, marriage or ordination Mass was created.

The new Code simply states that, "a person who has received the Most Holy Eucharist may receive it again on the same day only during the celebration of the Eucharist in which the person participates." Also, if the first reception of Holy Eucharist is at

Mass, the second must be at Mass as well and not a Communion Service for example.

There is one exception. Canon law states, “even if they have received Communion in the same day, those who are in danger of death are strongly urged to receive again.” This means that Holy Eucharist given as Viaticum may be received regardless of how many times Eucharist has been received during the day.
