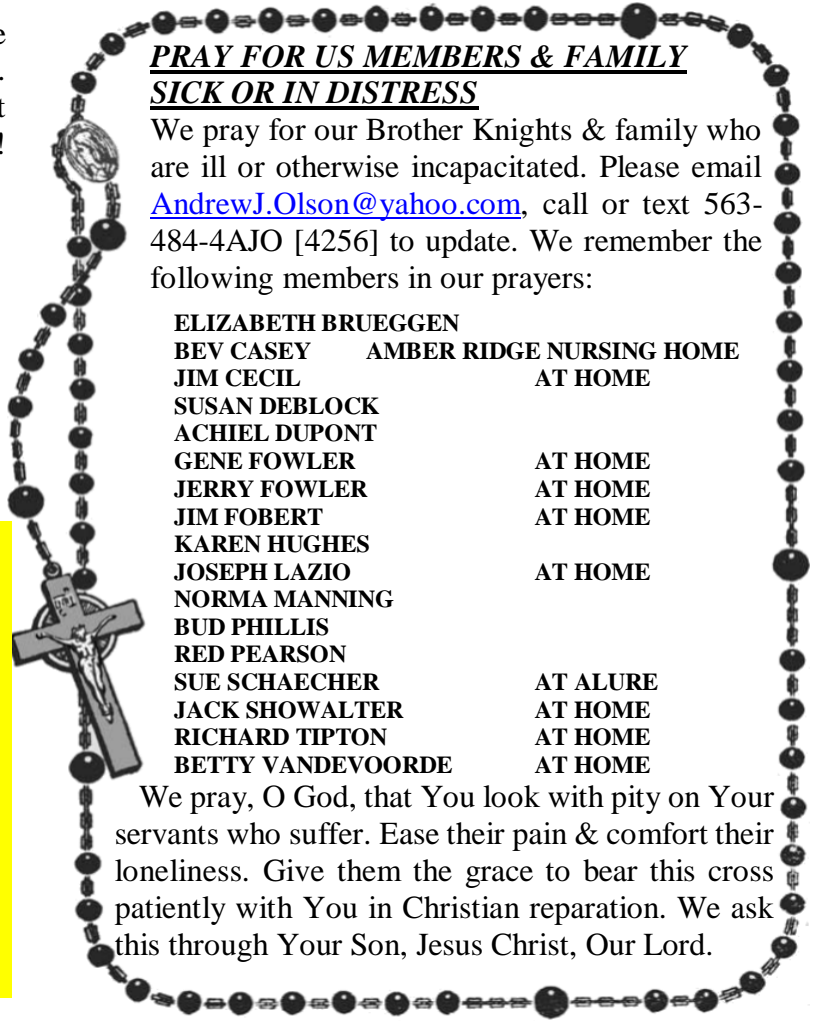

DEACON'S QUESTION BOX

Why Are There Two Versions Of The Glory Be?

What we call the 'Glory Be' is named the doxology. The word Doxology comes from the Latin referring to an oral expression of praise and glorification. It first appeared in English around 1645.

When I was in Iowa City during the initial recovery from my stroke I was ventilated and was on the ventilator long enough that it affected my throat. Once I was back in Rock Island Ryan, the manager of the therapy department at the hospital decided that one good way for me to accomplish some speech therapy was for the two of us to pray the liturgy of the hours together in the Chapel of the hospital. He wanted to learn how to say the liturgy of the hours

and I really wanted to fulfill my obligation to say it. So this was a win-win. Each morning he would put me in a wheelchair and we would go down to the Chapel and sit in front of the Tabernacle and pray the liturgy in chorus. The doxology is the closing of many parts of the liturgy of the hours. Ryan was confused the first time we went through it because as written in the liturgy of the hours the doxology reads “Glory to the Father, and to the Son, and to the Holy Spirit as it was in the beginning, is now, and will be forever. Amen.” Of course Ryan learned it in the traditional form “Glory be to the Father, and to the Son, and to the Holy Spirit. As it was in the beginning, is now, and ever shall be, world without end. Amen.” Given how ancient the doxology is the question arose why they aren’t the same? The liturgy of the hours is usually referred to as the Breviary. The Breviary was revised by Rome in 1970. The official version was promulgated in Latin as is true of all liturgical rites. The English translation of the conclusion of the Glory Be was different from the one more commonly known and used exactly why this was done was not then clear and is still not clear. The principles of liturgical translation were different in 1970 so one possible explanation was that the translation seemed smoother than a literal translation from Latin to English. Some members of the translation committee suggested it was more accurate. To be fair, the Latin of the final phrase of the Glory Be is difficult to translate smoothly into English. A literal rendering would be, “as it was in the beginning, and is now, and is always, and unto ages of ages.” As you can see, “world without end” is not really what the Latin says. “Unto the ages of ages” is basically a way of saying, “for a very long time,” or, more simply, “forever” — hence the shorter version.

That said, the version of the Glory Be known by the vast majority of Catholics including Ryan is the traditional one, which ends “world without end.” And thus there are many stumbles when people less familiar with the Breviary pray it together with those experienced in praying it. And I admit that when praying the Rosary with a group of people I often stumble because I tend to use the doxology from the Breviary because that’s the one I’m used to saying multiple times a day. The process to re-translate the English version of the Breviary is underway using the same translation standards that brought us the current version of the Mass texts. It is expected that the Glory Be will return to its traditional form when the new version is published and that will help avoid the issues that arise when there are two different forms.

PRO-LIFE MESSAGE (PART ONE)

Many people still have questions about whether Planned Parenthood does any good work, or is it an evil corporation pushing abortion on demand to make a profit. Sorting through what’s true and what’s

not when it comes to Planned Parenthood can be difficult. The nation’s largest abortion provider hides behind a veneer of marketing and misinformation. But beneath the smoke and mirrors, the facts speak for themselves. And these facts say loudly and clearly that abortion is the core mission of this organization that kills 947 babies every day in America. So let’s learn the facts.

1. Who funds Planned Parenthood?

According to PP 2019-2020 annual report, its funding comes from government health services reimbursements and grants (38%), (actually from American Tax payers), private contributions and bequests (31%), non-governmental health services revenue (22%), and other sources (9%). By law, taxpayer money cannot fund abortions, but money is fungible. When an organization has a large amount of money, it can shift funds around to fund whatever it wants. Taxpayer dollars may not go directly toward killing babies, but the fact is that the government (taxpayers) gives Planned Parenthood millions, and the organization can spread its money around however it wants to. According to the Lozier Institute, which analyzed this latest annual report: “Taxpayer funding in the form of government grants, contracts, and Medicaid reimbursements hit **\$618.1 million, or almost \$1.7 million per day**—an annual increase of \$1.3 million from the previous year to make up **38% of Planned Parenthood’s overall revenue.**”

2. How much is Planned Parenthood worth?

According to the 2019-2020 annual report, Planned Parenthood’s assets are just over two billion. Its revenue for that time period was \$1.641 billion.

3. How many abortions does Planned Parenthood do each year?

PP killed 354,871 preborn babies during the 2019-2020 fiscal year. At an approximate charge of \$600/abortion, that equates to about \$583,350 every day! So while Planned Parenthood may deny it, abortion is a huge chunk of its income.

4. What does Planned Parenthood mean when it claims abortion is 3% of its total services?

PP counts each service it provides as a unique interaction (a “discrete clinical interaction”) even if one person received multiple services. So, for instance, if a woman goes into PP for a pregnancy test and says that she’s worried that her boyfriend is cheating on her, she would likely receive an exam, STD testing, a pregnancy test, and a prescription (for the STD, birth control, or maybe even the abortion pill), and abortion counseling (if pregnant). Thus, this one woman received 4-5 (or more) services. Planned Parenthood records each service individually rather than recording multiple services under one person. So, when it divides the number of abortions by all of these services, the final number comes out to a little over 3%. Which is really a myth.

5. Did Planned Parenthood really sell baby body parts?

Yes! In 2015, a group of journalists working with The Center for Medical Progress—an organization dedicated to the monitoring and reporting of medical ethics—released the first of several damning videos that showed Planned Parenthood employees discussing the sale of portions of aborted babies to labs.

While these videos horrified the country and many claimed that founder David Daleiden and others lied and altered the videos, outside auditors proved the videos were not altered. Court cases continue, but the footage speaks for itself. For example, in one video Dr. Mary Gatter of PP talks about the best way to crush a baby to ensure that the organs that would be for sale would remain whole. Another worker, Holly O'Donnell, claims that she was ordered to "cut through the face of a baby whose heart was still beating AFTER an abortion to harvest his brain." Others, such as Dr. Deborah Nucatola and Dr. Carolyn Westhoff, were caught on tape bragging about the various organs they were able to procure. Most recently, CMP released a video featuring a PP official's sworn deposition testimony describing "infants born alive and either harvested for organs or left to die inside abortion clinics." This is truly horrific!!

6. What is the difference between Planned Parenthood's national office and its affiliates?

Headquartered in New York City, the Planned Parenthood Federation of America is the name for the national office that oversees roughly 50 affiliates. Though it operates no medical centers of its own, its affiliates operate 653 centers—387 of which commit surgical or abortion pill abortions. In addition, **PPFA mandates that every affiliate must have at least one facility that provides surgical or medical abortions.** Planned Parenthood now runs 53% of all surgical/medical abortion facilities in America.

7. What services does Planned Parenthood provide?

Though abortion is Planned Parenthood's proverbial "cash cow," the organization does offer other services, including men's and women's health services; pregnancy testing and services; general healthcare; HIV services; and STD testing, treatment, and vaccines. Planned Parenthood—the progeny of Margaret Sanger—continues, of course, to offer birth control. However, the organization fails to mention the harm that birth control can do to women. Never does it mention the fact that hormonal contraception can cause permanent damage or death. And never does it mention that the pill kills a preborn baby one third of the time. In addition, PP offers emergency contraception, claiming nonchalantly that "accidents happen." It also offers the abortion pill—a two-pill regimen that kills and expels the preborn baby, all while the woman is home alone. PP doesn't mention the dangerous side effects of the abortion pill for the mother or the fact that hemorrhaging and other problems can send her to the emergency room.

8. Will women lose access to necessary health services if Planned Parenthood were defunded?

Absolutely not! In the US, we have about 1,400 federally qualified health centers. In addition, there are over 13,000 federally qualified health center service sites that do the same things PP does—*except abortions.* People don't need Planned Parenthood. Planned Parenthood needs people in order to make money.
