Subject: Future Fund Subcommittee Report

Here are the results from the Straw Poll Vote we had at our Council meeting, Thursday March 9. I have attached the document used as our ballot.

We received 24 ballots with 45 votes. Three ballots only voted for one choice and one ballot only had checks on each choice so I gave each vote 1.5 points.

As noted on the ballot. 1st place votes received 2 points and 2nd place votes received 1 point each. As noted above, one ballot received 1.5 points for each unranked vote.

I am giving each of the four options listed a name. These are shown below in the order they were listed on the straw ballot.

I show the voting results with points shown at the end of each line.

<ol> <li>Investment only</li> </ol>	20 votes, 11 @ 1 <sup>st</sup> and 8 @ 2 <sup>nd</sup> and 1 @ 1.5	31.5 points
2. Investment with pay out	17 votes, 6 @ 1 <sup>st</sup> and 10 @ 2 <sup>nd</sup> and 1 @ 1.5	23.5 points
<ol><li>Knights owned clubhouse</li></ol>	2 votes, 1 @ 1 <sup>st</sup> and 1 @ 2 <sup>nd</sup>	3 points
<ol><li>Knights leased meeting space</li></ol>	6 votes, 5 @ 1 <sup>st</sup> and 1 @ 2 <sup>nd</sup>	11 points

Clearly option 1 is the top choice for this group of voters. This option describes a reinvestment of the money with no option to spend any of it other than what the investment earns (interest).

83% of the voting Knights chose this option as either 1st or 2nd choice. It received 46% of the points.

The 2<sup>nd</sup> choice is option 2 which is also an investment option, but includes a mechanism to spend a portion of the principal of the investment each year.

71% of the voting Knights chose this option as either 1st or 2nd choice. It received 34% of the points.

The two building options received much less support.

Option 3, clubhouse, was chosen by 9% of the voting Knights. It received 4% of the points.

Option 4, leased space, was chosen by 26% of the voting Knights. It received 16% of the points.

While the investment type fund options are clearly favored by those who voted (only one person did not vote for either option 1 or 2), we only had 24 of over 300 members participate in this vote, less than 8% of our membership. I do not feel that it is appropriate to eliminate any option.

My recommendation is that we continue to pull together a proposal to vote on all 4 options. The Subcommittee is working together to reword the options more carefully and set up secondary votes for each option.
